I agree to the following terms and conditions for participation in the NNPS/TNCC Early College Program. As a participant, I will:

1. Follow Thomas Nelson Community College rules and regulations, academic honor code, and the Student Rights and Responsibility Handbook rules and regulations required by Newport News Public Schools.
2. Maintain 95% or better attendance.
3. Consistently complete all assignments including homework, projects, and class/community service activities.
4. Actively engage in the learning process.
5. Submit high quality work by deadlines.
6. Maintain a minimum cumulative 2.5 GPA and abide by the Academic Review Process
7. Exemplify the highest degree of academic and personal integrity. Cheating, plagiarism, repeated class disruptions, and/or consistent discipline/behavior/attendance/tardiness problems will be grounds for immediate dismissal from the program.
8. Make an effort to schedule recreation, medical and other appointments outside of class time.
9. Attend student orientation sessions and all activities planned for the program.
10. Meet high school graduation requirements for an Advanced Studies Diploma by the end of first semester of senior year. **Successfully complete English 111 & English 112 with a grade of "C" or better to qualify to go on campus in the spring.**
