# Title I, Part A

Title I, Part A (Title I) of the Elementary and Secondary Education Act (ESEA), as amended by the Every Student Succeeds Act (ESSA) provides financial assistance to school districts and schools with high numbers or high percentages of children from low-income families to help ensure that all children meet challenging state academic standards.

Federal funds are currently allocated through four formulas based primarily on census poverty estimates and the cost of education in each state.

### School Improvement Grant

School Improvement Grants (SIGs), authorized under section 1003(g) of Title I, are competitive sub-grants awarded to school districts that demonstrate the greatest need for the funds and the strongest commitment to use the funds to provide adequate resources in order to substantially raise the achievement of students in their lowest-performing schools.

The schools are further designated according to the level of supports and interventions needed: comprehensive supports and interventions (CSI), additional targeted supports and interventions (ATSI), and targeted supports and interventions (TSI). CSI schools are title I only. ATSI and TSI schools both title I and non-title I. There are currently 9 SIG schools in NNPS, 4 middle and 5 elementary.

# Title I, Part D

The purpose of Title I, Part D is:

- to improve educational services for in local and State institutions for neglected or delinquent children.
- to provide such children and youth with the services needed to make a successful

transition from institutionalization to further schooling or employment; and

• to prevent at-risk youth from dropping out of school, and provide dropouts, and children and youth returning from correctional facilities or institutions for neglected or delinquent children and youth, with a support system to ensure their continued education.
