## Job Summary

Position is responsible for providing clerical office support in a school office.

# **Essential Duties**

- 1. Serves as secretary for the school principal.
- 2. Drafts memos and letters; proofreads all outgoing correspondence.
- 3. Compiles information from various sources for records and reports.
- 4. Acts as receptionist, receiving visitors, parents, teachers and students.
- 5. Confers with students, parents, salesmen, and others, answering inquiries and disseminating information, personally and over the phone.
- 6. Performs computations and posts to statistical records.
- 7. Maintains office files, account records, and a variety of other records.
- 8. Maintains fund accounts, makes trial balances and accounts for funds received.
- 9. Prepares bills for payment.
- 10. Maintains files and records.
- 11. Coordinates office responsibilities.
- 12. Performs other duties as requested.
- 13. Models nondiscriminatory practices in all activities

Must be able to perform and complete multiple tasks during any given day.

the telephone; ability to understand and follow oral and written instructions; physical agility to lift up to 25 pounds.
